#### **Old Business:**

There are four different versions of the USCA Constitution and Bylaws floating around. The most recent is dated 2016 though there was no mention of it being adopted at the 2016 annual meeting.

- Approve 2016 Constitution/Bylaws and discard all prior versions

- Amend 2016 Constitution/Bylaws:
  - Remove: Article I, F.5 language regarding filling vacant board positions
  - Add: Article I, F.5
    - "Vacant board member positions will be filled from nominations by members via the magazine, Sidecar.com or at an annual meeting. Nominees will be voted on by the board."

This amendment to the Constitution and Bylaws is recommended by the Board to be approved by the members at the 2022 meeting.

- The bylaws specify that expenditures less than \$500 may be made by the president's sole discretion. Amounts above \$1000 must be approved by the President and Treasurer. Amounts above \$4000 must be approved by the board What about \$500 \$1000? Further discussion to be conducted between President and L. Coltharp.
- Authorize the Board to conduct banking on behalf of the USCA per the attached resolution.

 Authorize President and Treasurer to be official signers on the USCA General bank account. Copies of minutes to document the identity of the officers authorized to sign documents.
